

PROOF OF RESIDENCE

ALL PROOF OF RESIDENCE DOCUMENTS MUST **INCLUDE THE VOTER'S NAME AND CURRENT RESIDENTIAL ADDRESS**

- BANK STATEMENT - NOT A CREDIT CARD STATEMENT
- BILLING STATEMENTS & COLLECTION NOTICES FROM A GOVERNMENTAL ENTITY
- CHECK OR OTHER DOCUMENT ISSUED BY A UNIT OF GOVERNMENT
- CONCEAL CARRY LICENSE
- CORRESPONDENCE FROM A FEDERALLY RECOGNIZED NATIVE AMERICAN TRIBE LIVING IN WISCONSIN
- COURT NOTICES & PAPERWORK
- FEDERAL STUDENT LOAN CORRESPONDENCE AND NOTICES
- FISHING & HUNTING LICENSES
- FOOD STAMPS, WI WORKS, WI SHARES & BADGERCARE NOTICES & CORRESPONDENCE
- HIGH SCHOOL (public) - TECHNICAL COLLEGE & PUBLIC UNIVERSITY CORRESPONDENCE & DOCUMENTS, INCLUDING: ADMISSIONS CORRESPONDENCE, FINANCIAL AID NOTICES, REPORT CARDS & SCHEDULES
- ID CARD OR LICENSE ISSUED BY A WISCONSIN GOVERNMENTAL BODY OR UNIT
- ID CARD ISSUED BY AN EMPLOYER IN THE NORMAL COURSE OF BUSINESS & BEARING A PHOTO OF THE CARD HOLDER, BUT NOT INCLUDING A BUSINESS CARD
- MEDICARE NOTICES AND MEDICARE EXPLANATION OF BENEFITS (**NOT FROM 2ND PARTY PROVIDERS OR OTHER HEALTH INSURANCE PROVIDERS**)
- PAYCHECK OR PAYSTUB OR RECORD OF DIRECT DEPOSIT
- POLICE REPORTS
- PUBLIC LIBRARY RECORDS
- REAL ESTATE TAX BILL FOR THE CURRENT YEAR OR THE YEAR PRECEDING THE DATE OF THE ELECTION
- RESIDENTIAL LEASE THAT IS EFFECTIVE ON DATE OF REGISTRATION. (NOT VALID IF REGISTERING BY MAIL.)
- SOCIAL SECURITY & SSI NOTICES & BENEFITS STATEMENTS
- TAX REFUND CHECK
- UNIVERSITY, COLLEGE, OR TECHNICAL COLLEGE IDENTIFICATION CARD (**MUST INCLUDE PHOTO**) ONLY IF THE VOTER PROVIDES A FEE RECEIPT DATED WITHIN THE LAST 9 MONTHS.
- UTILITY BILL - GAS, ELECTRIC, TELEPHONE, WATER, CABLE, INTERNET-STATEMENT FOR THE PERIOD COMMENCING NO EARLIER THAN 90 DAYS BEFORE REGISTRATION.
- VEHICLE REGISTRATIONS
- WI DRIVER LICENSE - CURRENT AND VALID OR STATE ID CARD.
